### **PTAC Biannual Meeting**

May 1-2, 2024, Bethesda, Maryland

#### **Program Accreditation/Reaccreditation**

The ASHP and ACPE Boards of Directors approved the following survey site visit reports reviewed by the pharmacy technician accreditation commission (PTAC): 8 new programs and 14 previously accredited programs seeking reaccreditation. Midterm reports (19) and special case reports (20) were also reviewed. As of the date of the meeting, 256 programs are in the accreditation process which includes accredited programs and programs in candidate status.

#### **PTCB Update**

Ryan Burke, Director of Professional Affairs at PTCB, provided an update on PTCB's job analysis report with an expected creation and implementation date of August 2024 for the new preliminary exam blueprint. Online testing centers for both the CPhT and CSPT certification examinations became available in February 2024. A new Online series with interviews of employers investing in pharmacy technicians is also



being developed. The Inaugural Leadership Institute for Pharmacy Technicians met in May with plans to include multiple cohorts each year. The PTEC meeting will be held in Charleston, South Carolina July 11-13th.

#### **Legislative Updates**

Kyle Robb described key pharmacy technician policy hot topics including scopes of practice; oversight and supervision; training, education, and credentialing; and, pharmacy technician seats on boards of pharmacy (19 states and Puerto Rico currently have dedicated pharmacy technician board seats). Other key data pints include states that require pharmacy technicians to be licensed, registered or certified with the State Board of Pharmacy (48 plus Washington, DC and Puerto Rico) and states that have adopted formal training requirements for pharmacy technicians (41). ASHP advocacy for pharmacy technicians includes a new, technician product verification initiative with a goal of allowing all 50 states to allow this function. Currently, 28 states affirmatively permit some form of technician verification while 22 states do not authorize any form of technician verification. Policy variations among the states along with advocacy opportunities and development of an ASHP Technician Product Verification Model Legislation were discussed. ### Credit for Prior Experience and Non-traditional Pharmacy Education and Training Programs

PTAC voted to approve a path towards Credit for Prior Experience: The Pharmacy Technician Accreditation Commission (PTAC) supports mechanisms by which more candidates can complete accredited pharmacy technician training programs. The commission believes providing credit for prior experience is an important enhancement to making accredited training accessible to students. Policies are in development for how programs can utilize Credit for Prior Experience.

### Health System Pharmacy Leaders Toolkit for Advancement of Pharmacy Technicians

The Pharmacy Technician Education and Training Program Toolkit for Hospital and Health System Leaders has been finalized. The toolkit will provide pharmacy leaders with many resources from justifying and developing an accreditation-worthy program to ideas for career advancement and career ladders which provide opportunities for advancement and may improve retention. This information will also be useful for health system pharmacy leaders to share with their administrators.

A special thanks from PTAC to the current and past members that worked extensively to put the toolkit together (Janet Kozakiewicz, Matthew Rewald, Amisha Arya, Melissa Heigham, Tate Trujillo). The toolkit is now in the final phases for production to be distributed for use by health system directors of pharmacy and administrators.

#### The Pharmacy Technician Society<sup>sм</sup> (TPTS)

Hannah Vanderpool provided the Commission with an update on TPTS activities. Autumn Pinard shared the infographic template that the TPTS and PTAC/Accreditation Services Office (Amisha Arya and Sheri Roumell Fulfer) completed to publicize the role of the pharmacy technician. #### **Fundamentals of Accreditation**

Sam Calabrese, Vice President of Accreditation Services, presented an overview of the fundamentals of accreditation. The presentation provided a valuable perspective on the purpose of accreditation and associated standards with a focus on the value they bring to our programs. These perspectives, along with the state of current and future pharmacy technician practice, patient safety, and the importance of incorporating necessary elements of pharmacy technician education and training, will be considered as a standard revision is drafted. PTAC members appreciated the discussion and gained a broader perspective of the importance of accreditation to our programs and the public.

#### Standard Revision 2024-2025

PTAC members discussed the goals for the Standard revision process with an anticipated completion by July 2025.

#### **Annual Survey**

The 2024 Annual Survey is in the final stages of development with an anticipated release timeframe of late fall 2024.


