PTAC Biannual MeetingOctober 25-26, 2017 Bethesda, MD

PTAC held its biannual meeting October 25-26, 2017 in Bethesda, Maryland. In addition to reviewing survey reports and applications for new program directors, commission members also discussed progress on revisions to the ASHP/ACPE pharmacy technician training and education standards as one of the outcomes from the Pharmacy Technician Stakeholders Conference proceedings.

Program Accreditation/Reaccreditation

The Commission reviewed survey site visit reports for 11 new programs and 19 previously accredited programs seeking reaccreditation. Midterm reports (2) and special case reports

(14) were also reviewed along with 25 applications for new program directors. As of the date of the meeting, 264 programs are in the accreditation process which includes accredited programs and programs in candidate status.

New Draft Accreditation Standards for Pharmacy Technician Education and Training Programs

A writing group formed of representatives from major areas of pharmacy practice met in late summer to continue the work on development of new draft standards. The group included Tim Koch from Walmart, Mark Ey representing the community pharmacy sector, Donna Wall from PTAC, John Smith from PTAC, Sheri Roumell as a community college program director and lead surveyor, Harold Kornfuhrer as a lead surveyor, Barbara Lacher as a college program director and PTAC, Chris Ellison from ASHP, Rafael Saenz representing hospital practice, Lisa Lifshin from ASHP, Janet Silvester from ASHP, and Peter Vlasses from ACPE who also drafted the preamble to the standards.

Using the task analysis compiled by PTCB as the foundation for the work, the group was charged with evaluating required competencies and establishing timeframes for the didactic, simulation, and experiential components of training for both entry level and advanced education and training programs. Comments on the draft were solicited from all PTAC and Pharmacy Technician Stakeholders Conference Advisory Committee members and incorporated into the draft that is now available for public comment through March 23, 2018. The goal for approval of the new standards by the ASHP and ACPR boards of directors is June 2018 with target implementation beginning in January 2019.

The draft standards are available here. Comments, both general and specific, are welcomed and encouraged and must be received by March 23, 2018. Midyear Clinical Meeting Recap

Pharmacy Technician Forum

ASHP launched the new Pharmacy Technician Forum during the 2017 Midyear Clinical Meeting in Orlando, Florida. The decision to develop this enhanced membership home for pharmacy technicians was unanimously approved by the ASHP Board of Directors on September 29, 2017. The goals of this new forum include providing education, tools, and resources for pharmacy technicians to advance their careers and solidify their roles as members of an inter-professional patient-care team.

From ASHP CEO Paul Abramowitz: "Pharmacy technicians play a vital role in patient care and are the key to allowing pharmacists to spend their time providing direct patient care in hospitals, clinics, and all settings," ASHP's goal with the Pharmacy Technician Forum is to give our technician colleagues the respect they deserve as well as the tools they need to continue to professionalize and advance their careers. As the organization that for decades has led the way in elevating the role of pharmacy technicians, we believe that ASHP will serve as the perfect home for technicians who wish to take their careers to the next level and beyond."

The framework for the Pharmacy Technician Forum will include an executive committee that will advise ASHP on the optimal programs, education, tools, policies, and resources pharmacy technicians need to be successful in their careers. ASHP will also be dedicating a team of staff members to support the forum and will be charged with constantly seeking ways to support pharmacy technician members' needs and enhance their engagement in ASHP.

Gentile, Director of State Grassroots Advocacy and Political Action, ASHP during the 2017 Midyear Clinical Meeting in Orlando, Florida. The presentation included an overview of the results from the 2015 National Pharmacy Technician Workforce survey including new and emerging roles, job satisfaction; an update from the Pharmacy Technician Accreditation Commission; PTCB certification program changes; and, state regulations affecting pharmacy technicians. PTCB Updates

New Executive Director and CEO

The Board of Governors of the Pharmacy Technician Certification Board (PTCB) recently announced the appointment of William Schimmel as PTCB's new Executive Director and CEO. Changes to the Certified Pharmacy Technician Program

PTCB recently announced changes to Certified Pharmacy Technician (CPhT) Program that will go into effect on January 1, 2020. Changes included an updated education/training eligibility requirement for PTCB CPhT and updated Pharmacy Technician Certification Examination (PTCE) content outline. New Certification Program in Compounded Sterile Preparation

PTCB has launched the PTCB Certified Compounded Sterile Preparation Technician™ (CSPT™) Program. The CSPT™ Program is the first new certification program PTCB has offered since the organization was founded in 1995 with the introduction of its Certified Pharmacy Technician (CPhT) Program. To earn CSPT Certification, eligible CPhTs are required to: 1) pass the CSPT™ Exam, a 2-hour, 75-question exam; and 2) submit Competency Attestation documentation from a qualified supervisor.
