

#### **New Accreditation Standard in Effect**

The new Accreditation standard, a joint effort between the Accreditation Council for Pharmacy Education (ACPE) and ASHP, was approved in 2013 and revised earlier this year. This standard applies to all programs that undergo accreditation and is available on the ASHP website.

A guidance document, which provides more information and examples of evidence programs can provide to surveyors to show compliance with the standards, is also available. Finally, the *Model Curriculum, 3rd Edition* provides examples of student activities that will help them progress on the associated objectives.
